WHEREAS, on 8 March 2020, President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency Throughout the Philippines" due to COVID-19 pandemic;

WHEREAS, on 13 March 2020, the Quezon City Council declared Quezon City to be under a State of Calamity in furtherance of the said presidential proclamation;

WHEREAS, it is the policy of the local government of Quezon City to extend partnership and cooperation with humanitarian organizations and private entities in addressing health issues which affect its constituents;

WHEREAS, the Quezon City Government is committed to collaborate with various stakeholders in its efforts to prevent, mitigate, and contain the spread of COVID-19 within its territorial jurisdiction;

WHEREAS, the Quezon City Government has received various letters of intent to donate COVID-19 related items, such as but not limited to flu vaccines, medicines, vitamins and supplements, face masks, alcohols, hand sanitizers, air purifiers, toiletries and even food items that were used in Quezon City Government quarantine facilities and vaccination sites;

WHEREAS, the Quezon City Government continuously receive letters of intent to donate from individual and private sectors of goods and items related to COVID-19 response, hence, there is a need for the City Government to accept such donations in a timely and efficient manner to prevent spoilage and damages for the immediate use thereof for the benefit of Quezon City residents, frontliners and workers;

WHEREAS, the civic spirit during this time of COVID-19 pandemic of the officers and shareholders of the donors is greatly appreciated by the City Government;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to accept donations from private companies and other donors and execute the related Deed of Donation and Acceptance for the donation of COVID-19 related items to mitigate the effects of COVID-19 pandemic in Quezon City.
