RESOLUTION NO. B004; S - 2020

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

- WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated September 06, 2020 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on September 28, 2020, for seven (7) infrastructure projects of the City Government;
- WHEREAS, a total of eighteen (18) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS, during the scheduled public bidding held on September 28, 2020, seventeen (17) bid proposals were received and opened and, after examination of said documents, ten (10) were declared passed and their corresponding bid price read while seven (7) were declared failed and one (1) for nonsubmission of bidding documents;
- WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;
- NOW THEREFORE RESOLVED by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on September 28, 2020:

MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

TRICHES CONSTRUCTION AND TRADING a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 15-A Mabini Street, Burgos, Rodriguez, Rizal and herein represented by MR.. JAY RENOSO AMANSEC in his capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED BIKE LANE AT VARIOUS ROADS IN QUEZON CITY* (CLUSTER 3), VARIOUS BARANGAYS & PROJECT NO. 20-00013 and the City has accepted the Bid for SEVEN MILLION SIX HUNDRED FIFTY THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS & 84/100 CTVS. (P 7,650,288.84) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;

- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- That the Contractor hereby certifies that the site was regularly inspected and verified
- The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.


