



RESOLUTION NO. B008; S - 2020

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

- WHEREAS,** the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated October 30, 2020 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on November 23, 2020, for seven (7) infrastructure projects of the City Government;
- WHEREAS,** a total of fourteen (14) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS,** during the scheduled public bidding held on November 23, 2020, fourteen (14) bid proposals were received and opened and, after examination of said documents, thirteen (13) were declared passed and their corresponding bid price read while one (1) was declared failed;
- WHEREAS,** by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS,** evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;
- NOW THEREFORE RESOLVED** by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on November 23, 2020:



ANTONIO G. HERNANDEZ** in his capacity as **PRESIDENT** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED INSTALLATION OF MAIN ELECTRICAL SERVICE ENTRANCE OF LEANDRO LOCSIN SENIOR HIGH SCHOOL, BARANGAY KALIGAYAHAN & PROJECT NO. 20-00071** and the City has accepted the Bid for **FOUR MILLION FOUR HUNDRED FORTY SIX THOUSAND FORTY TWO PESOS & 37/100 CTVS.  6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.


