RESOLUTION ON THE RECOMMENDATION TO AWARD TO BROADFIELD ENGINEERING TECHNOLOGIES AND INTEGRATED SERVICES THE CONSULTANCY SERVICE FOR THE HIRING OF AN ENVIRONMENTAL CONSULTANCY FIRM TO RENDER SERVICES FOR THE ACQUISITION OF THE NECESSARY ENVIRONMENTAL-RELATED REQUIREMENTS FOR THE EIGHT (8) QUEZON CITY OWNED PUBLIC MARKETS

WHEREAS, a Request for Expression of Interest was posted in the PHILGEPS, Quezon City Website and at conspicuous places of Quezon City Hall premises for Consultancy Service for the Hiring of an Environmental Consultancy Firm to Render Services for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets;

WHEREAS, the Approved Budget Contract (ABC) is in the total amount of Two Million Five Hundred Fifty Three thousand and Forty (Php2,553,040.00) Pesos;

WHEREAS, two (2) prospective consultants responded to the invitation to bid and obtained eligibility documents within the scheduled issuance period, namely:

- 1. Broadfield Engineering Technologies and Integrated Services; and
- Ergons Project Management Consultant

WHEREAS, on December 01, 2020 the Bids and Awards Committee (BAC) conducted a preliminary assessment on the eligibility envelopes of the prospective bidders during the opening of eligibility requirements for consulting services bidding pursuant to Section 24.4.1 Rule VIII of the 2016 Revised IRR of R.A. 9184:

WHEREAS, both prospective consultants passed the detailed evaluation of bid proposal and was qualified in the shortlisting process pursuant to Section 24.4.2 Rule VIII and Sec. 24.5.3 Rule VIII of the 2016 Revised IRR of R.A. 9184;

WHEREAS, upon approval by the Bids and Awards Committee (BAC) on the recommendation of the Technical Working Group (TWG) for the qualification of the prospective Consultant to submit their technical and financial proposals on the next stage of the bidding process, the shortlisted Consultants were notified for submission of their technical and financial proposal for the opening of bid on December 21, 2020;

WHEREAS, during the opening of bid for technical proposal of the prospective Consultants on December 21, 2020, Broadfield Engineering Technologies and Integrated Services and Ergons Project Management Consultant submitted their technical and financial proposals;

WHEREAS, the Technical Working Group (TWG) conducted the detail evaluation on the technical bid proposals of Broadfield Engineering Technologies and Integrated Services and Ergons Project Management Consultant based on the following criteria pursuant to Sec.33.2.2 Rule IX of Revised IRR of R.A. 9184:

Consultancy Service for the Hiring of an Environmental Consultancy Firm to Render Services for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets

- 60% Experience and capability of the Consultant which include records of previous engagement and quality of performance in similar and other projects, the experience of the Consultant to the project and the individual experiences of the principal and key staff;
- 30% Quality of personnel to be assigned to the project; and
- 10% Plan of approach and methodology with emphasis on clarity, feasibility, comprehensiveness of the plan approach, quality of interpretation of project problems, risks and suggested solutions.

WHEREAS, the Terms of Reference for the Consultancy Service for the Hiring of an Environmental Consultancy Firm to Render Services for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets required for the Quality Based Evaluation method on the bid proposals of the prospective consultants;

WHEREAS, the following are the result of the detailed evaluation on the technical proposals of the following prospective consultants:

WHEREAS, based on the result of the detailed evaluation procedure conducted on the technical proposal submitted by the Broadfield Engineering Technologies and Integrated Services and Ergons Project management Consultant both of them passed the minimum requirement for the technical proposal with a total score of 96% and 86% respectively;

WHEREAS, based on the Quality Based Evaluation method on the bid proposals from the prospective bidders as required in the Terms of Reference for this consultancy service requirement, the bid of Broadfield Engineering and Technologies Integrated Services emerged as the Highest Rated Bid;

WHEREAS, the Technical Working Group (TWG) recommended to the Bids and Awards Committee (BAC) for the opening of the financial proposal of Broadfield Engineering and Technologies Integrated Services for the public bidding for the Consultancy Service on the Hiring of an Environmental Consultancy Firm to Render Services for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets for the purpose of conducting negotiation with the said Consultant pursuant to Sec. 33.2.1.a. (iv) Rule IX of the 2016 Revised IRR of R.A. 9184;

WHEREAS, the Bids and Awards Committee (BAC) confirmed and approved the technical evaluation by the Technical Working Group on the Highest Rated Bid of the Broadfield Engineering and Technologies Integrated Services for this Consultancy Service public bidding;

WHEREAS, the Bids and Awards Committee (BAC) also approved for the opening of the financial proposal of Broadfield Engineering and Technologies Integrated Services for the public bidding for the Consultancy Service for the Hiring of an Environmental Consultancy Firm to Render Services for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets for the purpose of conducting negotiation with the said Consultant pursuant to Sec. 33.2.1.a. (iv) Rule IX of the 2016 Revised IRR of R.A. 9184;

WHEREAS, on December 23, 2020 the financial proposal of the prospective Consultant Broadfield Engineering and Technologies Integrated Services was opened and the submitted financial proposal of Two Million Three Hundred Eighty Five Thousand Eight Hundred Two (P2,385,802.00) Pesos was within the Approved Budget Contract (ABC) is in the total amount of Two Million Five Hundred Fifty Three thousand and Forty (Php 2,553,040.00) Pesos;

WHEREAS, pursuant to Sec. 33.2.5 Rule IX of the 2016 Revised Implementing Rules and Regulations of the Republic Act No. 9184, the Bids and Awards Committee (BAC) together with Broadfield Engineering and Technologies Integrated Services successfully concluded the negotiation process for the Consultancy Service for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets;

WHEREAS, as required under Sec. 34.2 Rule X of the Revised IRR of R.A. 9184, the Broadfield Engineering and Technologies Integrated Services submitted their latest income and business tax returns, and other appropriate licenses and permits required in the bidding documents;

WHEREAS, pursuant to Sec. 34.4 Rule X of the Revised IRR of R.A. 9184, upon confirmation and ascertainment of the Technical, Legal and Financial capability of Broadfield Engineering and Technologies Integrated Services to fulfill the obligation for Consultancy Service for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets, the Technical Working Group (TWG) recommended to the Bids and Awards Committee (BAC) to declare Broadfield Engineering and Technologies Integrated Services as the Highest Rated Responsive Bid (HRRB) and for the award of contract to Broadfield Engineering and Technologies Integrated Service being bid out;

WHEREFORE, the Bids and Awards Committee (BAC), confirms and approves the recommendation of the Technical Working Group (TWG) to declare Broadfield Engineering and Technologies Integrated Services as the Highest Rated Responsive Bid (HRRB) for the consultancy service being bid out; FURTHER, the Bids and Awards Committee (BAC) also confirms and approves the recommendation of the Technical Working Group (TWG) for the award of contract to Broadfield Engineering and Technologies Integrated Services for the consultancy service being bid out; FINALLY RESOLVED, the Bids and Awards Committee (BAC) hereby recommends to the Head of the Procuring Entity (HOPE) to award the contract to Broadfield Engineering and Technologies Integrated Services for the Consultancy Service for the Acquisition of the Necessary Environmental-Related requirements for the Eight (8) Quezon City Owned Public Markets.
