**RESOLUTION NO. B014; S - 2020**

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS  
AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS**

**WHEREAS,** the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) uploaded an Invitation to Bid (ITB) dated December 29, 2020 in QC WEBSITE and at conspicuous places in Quezon City Hall for the public bidding to be held on January 19, 2021, for eight (8) infrastructure projects of the City Government;

**WHEREAS,** a total of sixteen (16) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;

**WHEREAS,** during the scheduled public bidding held on January 19, 2021, sixteen (16) bid proposals were received and opened and, after examination of said documents, twelve (12) were declared passed and their corresponding bid price read while four (4) were declared failed;

**WHEREAS,** by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;

**WHEREAS,** evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;


**NOW THEREFORE RESOLVED** by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on January 19, 2021:






