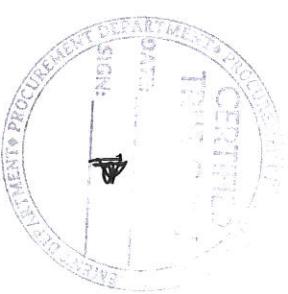
**AWARDING THE CONTRACT FOR THE ACQUISITION OF GOODS AND SERVICES THROUGH
