A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO REHUB REAL ESTATE, INC. FOR THE CONSTRUCTION AND OPERATION OF REHUB, A SIX (6)-STOREY COMMERCIAL BUILDING WITH PENTHOUSE LOCATED AT LOT 12-B, NO. 60 SCT. CHUATOCO CORNER CHAMPACA STREETS, BARANGAY ROXAS, DISTRICT IV, QUEZON CITY, AS PROVIDED UNDER THE PROVISIONS OF ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Rehub Real Estate, Inc. is applying for the issuance of a Certificate of Exception for the construction and operation of Rehub, a Six (6)-Storey Commercial Building with Penthouse located at Lot 12-B, No. 60 Sct. Chuatoco corner Champaca Streets, Barangay Roxas, District IV, Quezon City;

WHEREAS, the Sangguniang Barangay of Roxas and the residents thereat interposed no objection to the aforementioned project;

WHEREAS, the applicant has complied with all the requirements relative to its application and the issuance of the Certificate of Exception;

WHEREAS, though the project site is classified as Commercial Zone, it exceeded the floor area ratio, hence, the need to comply with the parking requirements of the zoning ordinance;

WHEREAS, under the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Certificate of Exception is required in the aforementioned project.
