A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO IKHEA LIGHTINGS, INC. FOR THE CONSTRUCTION OF A TWO (2)-STOREY WAREHOUSE BUILDING (AS BUILT) LOCATED AT LOTS 7 AND 8, BLOCK 130, TOLENTINO STREET, BARANGAY SAN ANTONIO, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, IKHEA Lightings, Inc. is applying for the issuance of a Certificate of Exception for the construction of a Two (2)-Storey Warehouse Building (As Built) located at Lots 7 and 8, Block 130, Tolentino Street, Barangay San Antonio, District I, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the purpose of the application is to comply with the parking requirement and zoning classification prescribed by the zoning ordinance;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

WHEREAS, the applicant has submitted the necessary and mandatory requirements in support of the proposed project and undertakes to comply with the provisions of existing laws, ordinances, and rules and regulations pertaining to public safety, environmental protection, and vehicular traffic.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to IKHEA Lightings, Inc. for the construction of a Two (2)-Storey Warehouse Building (As Built) located at Lots 7 and 8, Block 130, Tolentino Street, Barangay San Antonio, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
