A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE TWO (2) UNITS OF MOTOR VEHICLE (PASSENGER VAN) TO BARANGAY HOLY SPIRIT, QUEZON CITY, AND TO TRANSFER THE OWNERSHIP OF THE SAID ITEM TO THE SAID RECIPIENT WITHOUT COST.

Belmonte, to donate two (2) units of motor vehicle (passenger van) to Barangay Holy Spirit, Quezon City, and to transfer the ownership of the said item to the said recipient without cost.

RESOLVED FURTHER, that ownership of the same be transferred to the recipient, through a Deed of Donation, to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte, and Honorable Estrella C. Valmocina as Donor, and Punong Barangay Felicito A. Valmocina of Barangay Holy Spirit as Donee, with the City Government Department Heads of the City General Services Department (CGSD) and the Barangay and Community Relations Department (BCRD) as Witnesses.
