*WHEREAS, Police Brigadier General Remus Balingasa Medina belongs to the Philippine National Police Academy (PNPA) Class 1991 and appointed as District Director of Quezon City Police District (QCPD) effective February 3, 2022;*

*WHEREAS, PBGen. Medina served the country for almost three (3) decades in the field of law enforcement through different capacities and positions with the Philippine National Police (PNP);*

WHEREAS, prior to his stint as Director of the Philippine National Police Drug Enforcement Group (PNP DEG), PBGen. Medina was assigned in various commands where he held key positions such as Senior Executive Assistant to then PNP Chief Police General Debold Sinas, Chief Directorial Staff of Eastern Police District, National Capital Region Police Office (NCRPO);

WHEREAS, he became the Chief of Regional Intelligence Division of NCRPO, Chief of Regional Intelligence Division of Police Regional Offices 2 and 7, respectively;

WHEREAS, he became the Regional Chief Directorial Staff of Police Regional Office 9 and once served at the Special Action Force (SAF) for seventeen (17) years;

WHEREAS, it was worth noting that PBGen. Medina was trained in the United States in counter-terrorism and urban counter revolutionary warfare. He was also one of the SAF Officers who neutralized a band of Abu Sayyaf members who held hostage fellow inmates at the Bureau of Jail Management and Penology complex at Camp Bagong Diwa in Taguig City a few years ago;

WHEREAS, the outgoing QCPD District Director Antonio Yarra will relinquish his duties and responsibilities to PBGen. Remus Medina as the new District Director of the QCPD;

WHEREAS, PBGen. Medina will replace PBGen. Antonio Yarra, who was appointed as the new Regional Director of the Police Regional Office in CALABARZON;

WHEREAS, as a gesture of welcome and support, it is appropriate for the City Government to extend warmest felicitations to PBGen. Remus Medina for his incoming service to the City as the new QCPD District Director.
