RESOLUTION NO. SP-**8888**, S-2022

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CHAMBER OF COMMERCE AND INDUSTRY-QUEZON CITY (PCCI-QC) FOR THE DONATION SUPPORT IN THE AMOUNT OF THIRTY-ONE MILLION PESOS (PHP31,000,000.00), FOR THE SYSTEM ENHANCEMENT OF THE ONLINE UNIFIED BUSINESS APPLICATION SYSTEM (PHASE 3) OF THE BUSINESS PERMITS AND LICENSING DEPARTMENT OF QUEZON CITY.

WHEREAS, in Executive Order No. 47, Series of 2020, the City Mayor, Honorable Ma. Josefina G. Belmonte, turned the existing Ease of Doing Business and Automation Task Force into a Committee on Anti-Red Tape and Ease of Doing Business (CART-EODB);

WHEREAS, under its expanded functions, duties and responsibilities as provided by Executive Order No. 47, the CART-EODB is mandated to streamline all city government services by making relevant procedural steps more efficient to meet the deadlines under the EODB law;

WHEREAS, for faster transactions, the digitization and computerization of various systems are encouraged, including the establishment of a back-end system and intranet interconnecting all offices and the use of electronic documents instead of hard copies, among others;

WHEREAS, the Business Permits and Licensing Department (BPLD) launched the QC Biz Easy Online Unified Business Permit Application System (OUBPAS), an online processing system of business permits applications;

WHEREAS, the Philippine Chamber of Commerce and Industry-Quezon City (PCCI-QC), donated in favor of the Quezon City Government an amount of Thirty-One Million Pesos (Php31,000,000.00) pursuant to its duly adopted Board Resolution No. 22-004 dated March 3, 2022;

WHEREAS, as per Board Resolution No. 22-004, the donated amount of Php31,000,000.00 shall be utilized to fund the necessary upgrading of the OUBPAS for new modules, enhancements to existing modules and system integration for online tax assessments, automated delivery system, QC e-Payment systems, among others and linking with PCCI-QC for advertisement and membership registration;

WHEREAS, the generosity of the officers and members of PCCI-QC in support of the City's automation efforts is greatly appreciated by the Quezon City Government;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, as the Chief Executive of the City Government, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Philippine Chamber of Commerce and Industry-Quezon City (PCCI-QC) for the donation support in the amount of Thirty-One Million Pesos (Php31,000,000.00), for the system enhancement of the Online Unified Business Application System (Phase 3) of the Business Permits and Licensing Department of Quezon City.
