RESOLUTION NO. SP-8892, S-2022

A RESOLUTION STRONGLY SUPPORTING THE PASSAGE INTO LAW OF HOUSE BILL NO. 10647, ENTITLED "AN ACT GRANTING ADDITIONAL BENEFITS TO FILIPINO CENTENARIANS, RECOGNIZING OCTOGENARIANS AND NONAGENARIANS, AND APPROPRIATING FUNDS THEREFOR", AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 10868, OTHERWISE KNOWN AS THE CENTENARIANS ACT OF 2016.

WHEREAS, it is enshrined in the 1987 Philippine Constitution that the State shall extend full support in the continuing process of alleviating the well-being of the elderly and their continued meaningful contribution and participation in the mainstream of the society;

WHEREAS, the House of Representatives approved on Second Reading House Bill No. 10647 which aims to provide monetary benefits to senior citizens who have reached eighty (80), eighty-five (85), ninety (90), ninety-five (95) and one hundred one (101) years of age;

WHEREAS, the aforementioned House Bill amends Republic Act No. 10868 by inserting a new subsection that provides for the grant of cash gifts in the amount of One Million Pesos (Php1,000,000.00) to those who reached the age of one hundred one (101) years, and cash benefits for octogenarians and nonagenarians in the amount of Twenty-Five Thousand Pesos (Php25,000.00);
