A RESOLUTION RENEWING THE SPECIAL PERMIT OF TOPNOTCH BINGO TREND, INC. TO OPERATE AN ELECTRONIC GAMES AND BINGO GAMES AT NO. 94 TIMOG AVENUE, BARANGAY SOUTH TRIANGLE, DISTRICT IV, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Topnotch Bingo Trend, Inc. is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at No. 94 Timog Avenue, Barangay South Triangle, District IV, Quezon City;

WHEREAS, Topnotch Bingo Trend, Inc. is primarily engaged in the business of Electronic Games and Bingo Games;

WHEREAS, to enable the applicant to operate an Electronic Games and Bingo Games in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Topnotch Bingo Trend, Inc. is requesting the City Council for the renewal of a Special Permit to operate an Electronic Games and Bingo Games.
