RESOLUTION NO. SP-**8901**, S-2022

A RESOLUTION RENEWING THE SPECIAL PERMIT OF MILLENIUM BINGO FUN GAMING CORPORATION TO OPERATE A BINGO HALL/ELECTRONIC GAMES (E-GAMES) LOCATED AT THE 3<sup>RD</sup> FLOOR OF FCM BUILDING, DON MARIANO MARCOS AVENUE CORNER REGALADO AVENUE, FAIRVIEW, DISTRICT V, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Millenium Bingo Fun Gaming Corporation is a corporation formed and registered under Philippine laws located at 3<sup>rd</sup> Floor of FCM Building, Don Mariano Marcos Avenue corner Regalado Avenue, Fairview, District V, Quezon City and applying for the renewal of its Special Permit to operate a Bingo Hall/Electronic Games (E-Games);

WHEREAS, sometime in 2004 and 2011, the City Council passed an Ordinance granting a Special Permit to the applicant to operate the said Bingo Hall/Games docketed as Ordinance No. SP-1442, S-2004 and Ordinance No. SP-2110, S-2011;

WHEREAS, to enable Millenium Bingo Fun Gaming Corporation to continue its legal business operation, there is a need to renew the said Special Permit;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City Ordinances, authorizes the City Council to grant special permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Millenium Bingo Fun Gaming Corporation to operate a Bingo Hall/Electronic Games (E-Games) located at the 3<sup>rd</sup> Floor of FCM Building, Don Mariano Marcos Avenue corner Regalado Avenue, Fairview, District V, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

*RESOLVED FURTHER, that the authority to operate a Bingo Hall/ Games granted herein shall be subject to the following conditions:*

- a. The holding of Bingo Hall/Electronic Games (E-Games) shall be in accordance with the Rules and Regulations promulgated by PAGCOR;*
- b. The operation of Bingo Hall/Electronic Games (E-Games) shall not include the playing of games not related to or other than Electronic Games; and*
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the abovementioned.*

*RESOLVED FURTHERMORE, that Millenium Bingo Fun Gaming Corporation shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.*

*RESOLVED FINALLY, that this Special Permit to operate a Bingo Hall/Electronic Games (E-Games) shall be valid for a period of two (2) years and may be renewed by the City Council.*
