RESOLUTION NO. SP-8913, S-2022

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A CONTRACT WITH ERLINDA DE LEON MENDOZA FOR THE LEASE OF HER PROPERTY LOCATED AT NO. 0034 Q5 (03) V. LUNA AVENUE, BARANGAY MALAYA, DISTRICT IV, QUEZON CITY, TO BE USED AS A TEMPORARY BARANGAY HALL OF SAID BARANGAY.

WHEREAS, Ms. Erlinda De Leon Mendoza is the owner of a certain real property (house and lot) located at 0034 Q5 (03) V. Luna Avenue, Barangay Malaya, District IV, Quezon City;

WHEREAS, Barangay Malaya desires to lease the property to be used as its temporary Barangay Hall for the exclusive use and benefit of the residents of Barangay Malaya and the owner is willing to lease out the same for the said purpose;

WHEREAS, the amount of monthly rental is Twenty-Five Thousand Pesos (Php25,000.00) that will be deposited in a form of check every first banking day of the month;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
