RESOLUTION NO. SP-\_\_\_\_\_, S-2022

A RESOLUTION GRANTING A FRANCHISE TO LYDIA'S LECHON QUEZON CITY, INC., FOR THE OPERATION OF A SLAUGHTERHOUSE AT LOT 4, BLOCK 4, CAROL STREET, SAN MIGUEL SUBDIVISION, TANDANG SORA, DISTRICT VI, QUEZON CITY, IN ACCORDANCE WITH THE PROVISIONS OF ARTICLE IV OF ORDINANCE NO. SP-2505, S-2016, OTHERWISE KNOWN AS THE REVISED QUEZON CITY VETERINARY CODE OF 2016.

*WHEREAS, the Lydia's Lechon Quezon City, Inc. made representation with the Quezon City Council seeking franchise for the operation of a slaughterhouse at Lot 4, Block 4, Carol Street, San Miguel Subdivision, Tandang Sora, District VI, Quezon City;*

*WHEREAS, Section 7 of City Ordinance No. SP-2505, S-2016, otherwise known as the Revised Quezon City Veterinary Code of 2016, requires, among others, all Abattoir/Slaughterhouse operation to secure a franchise from the Quezon City Council;*

*WHEREAS, the operation of a slaughterhouse by Lydia's Lechon Quezon City, Inc., at Lot 4, Block 4, Carol Street, San Miguel Subdivision, Tandang Sora, District VI, Quezon City for several decades is vested with public interest by supplying meat requirements of the residents of San Miguel Subdivision;*

*WHEREAS, Lydia's Lechon Quezon City, Inc. has complied with all the necessary requirements for the issuance of a franchise for the operation of a slaughterhouse at Lot 4, Block 4, Carol Street, San Miguel Subdivision, Tandang Sora, District VI, Quezon City;*

WHEREAS, the Sangguniang Barangay of Barangay Tandang Sora interposes no objection to the operation of the said slaughterhouse because of the benefits and development being realized out of the said slaughterhouse and a consultation with the community was properly conducted.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a franchise to Lydia's Lechon Quezon City, Inc., for the operation of a slaughterhouse at Lot 4, Block 4, Carol Street, San Miguel Subdivision, Tandang Sora, District VI, Quezon City, in accordance with the provisions of Article IV of Ordinance No. SP-2505, S-2016, otherwise known as the Revised Quezon City Veterinary Code of 2016.

RESOLVED FURTHER, that the franchise herein granted shall be valid for a period of five (5) years from the date of approval of this Resolution.
