A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO NORA SAN PABLO BORDEOS (PILIPINAS SHELL PETROLEUM CORPORATION) FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION LOCATED AT NO. 184 KATIPUNAN AVENUE, BARANGAY BLUE RIDGE A, DISTRICT III, QUEZON CITY.

WHEREAS, Nora San Pablo Bordeos is applying for the issuance of a Special Use Permit to be used for the construction and operation of a gasoline refilling station located at No. 184 Katipunan Avenue, Barangay Blue Ridge A, District III, Quezon City;

WHEREAS, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Zoning Ordinance of 2016, a Special Use Permit shall be required for the construction and operation of a gasoline refilling station, subject to the authorization by the City Council through a Resolution;

WHEREAS, the members of the Sangguniang Barangay concerned and the residents nearby the place of business did not interpose any objection to the construction and operation of the said business establishment;

WHEREAS, the construction and operation of a gasoline refilling station in the area will not adversely affect the public welfare, but instead generate employment opportunity and promote the development of the city's economy.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Nora San Pablo Bordeos (Pilipinas Shell Petroleum Corporation) for the construction and operation of a gasoline refilling station located at No. 184 Katipunan Avenue, Barangay Blue Ridge A, District III, Quezon City.
