RESOLUTION NO. SP-8929, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO REVLIS CARWASH SERVICES FOR THE CONSTRUCTION AND OPERATION OF A ONE (1)-STOREY COMMERCIAL BUILDING WITH OFFICE (AS BUILT) LOCATED AT LOT A, NO. 83 DON MANUEL AGREGADO STREET, BARANGAY MAHARLIKA, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Revlis Carwash Services is applying for the issuance of a Certificate of Exception for the construction and operation of a One (1)-Storey Commercial Building with Office (As Built) located at Lot A No. 83 Don Manuel Agregado Street, Barangay Maharlika, District I, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required in the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the application for the issuance of a Certificate of Exception is being requested for the purpose of complying with the zone classification of the project location;

WHEREAS, Revlis Carwash Services has complied with all the necessary and mandatory requirements relative to its application.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Revlis Carwash Services for the construction and operation of a One (1)-Storey Commercial Building with Office (As Built) located at Lot A, No. 83 Don Manuel Agregado Street, Barangay Maharlika, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
