SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF INTERNET CONNECTIVITY OF ROSARIO MACLANG BAUTISTA GENERAL HOSPITAL (RMBGH) - 25 MBPS

I. RATIONALE AND BRIEF BACKGROUND

Rosario Maclang Bautista General Hospital (RMBGH) is a healthcare institution providing patient treatment with specialized medical and nursing staff and medical equipment. RMBGH is accredited by DOH as a Level 2 hospital with a bed capacity of 107.

II. PROJECT DESCRIPTION

V. PROJECT STANDARDS & REOUIREMENTS

As part of the requirements in RA 9184, the Bidder must have completed a government or private contract that is similar in nature to this project within the last three (3) years equivalent to at least fifty (50%) of the approved budget for the contract (ABC)

The standards required hereof shall be limited to whatever should be required for the proper installation as listed in the scope of work.

VI. PROJECT DURATION

8 Months including installation. Billing will commence upon completion of installation, testing and commissioning of internet connectivity for Rosario Maclang Bautista General Hospital (RMBGH)

VII. APPROVED BUDGET FOR THE CONTRACT

The Approved Budget for the Contract (ABC) is TWO HUNDRED THOUSAND PESOS (P200,000.00)

The project cost shall be fixed and there shall be no price adjustments applicable for the duration of the contract except when the operations costs are increased by more than 10% as a result of any extraordinary circumstances as determined by the National Economic Development Authority (NEDA). Pursuant to the provision of RA 9184 and its IRR on contract price escalation, the Government Procurement Policy Board (GPPB) shall approve all contract price escalation.

VIII. BASIS OF PAYMENT

Monthly recurring charges upon installation. Billing date will commence upon completion of the installation.

IX. PENALTIES FOR BREACH OF CONTRACT

Failure to deliver the services according to tile standards and requirements set by the City shall constitute an offence anti shall subject the Contractor to penalties and/or liquidated damages pursuant to RA 9184 and its revised Implementing Rules and Regulations.

X. CANCELLATION OF TERMINATION OF CONTRACT

The guidelines contained in R4 9184 and its revised IRR shall be followed in the termination of any service contract. In the event the City terminated the Contract due to default insolvency, or for cause, it may enter into negotiated procurement pursuant to section 53 (d) of RA 9184 and its IRR.
