RESOLUTION NO. SP- 8857, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO DECIMAL PRINTING CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A TWO (2)-STOREY COMMERCIAL BUILDING (AS BUILT) LOCATED AT LOT 34, BLOCK 389, NO. 99 MATUTUM STREET, BARANGAY MANRESA, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Decimal Printing Corporation is applying for the issuance of a Certificate of Exception for the construction and operation of a Two (2)-Storey Commercial Building (As Built) located at Lot 34, Block 389, No. 99 Matutum Street, Barangay Manresa, District I, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the purpose of the application is to comply with the parking and zone classification prescribed by the zoning ordinance;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Decimal Printing Corporation for the construction and operation of a Two (2)-Storey Commercial Building (As Built) located at Lot 34, Block 389, No. 99 Matutum Street, Barangay Manresa, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance OF 2016.
