



## RESOLUTION NO. SV02; S - 2021

### DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS THROUGH ALTERNATIVE METHOD OF PROCUREMENT

**WHEREAS**, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Request for Quotation / Proposal (RFQ) dated September 30, 2021 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on October 5, 2021, for thirteen (13) infrastructure projects of the City Government;

**WHEREAS**, a total of thirteen (13) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;

**WHEREAS**, the QC-BAC-Infra issued Bid Bulletin No. 003-2021 for rescheduling of opening of Quotations to October 11, 2021;

**WHEREAS**, during the scheduled opening of quotation/offer held on October 11, 2021, seven (7) bid proposals were received and opened and, after examination of said documents, all were declared passed and their corresponding bid price read while six (6) were declared failed for non submission of bidding documents;

**WHEREAS**, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;

**WHEREAS**, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;

**NOW THEREFORE RESOLVED** by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on October 11, 2021:

JOSE SUÑER SALLADOR** in his capacity as **PRESIDENT** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **REHABILITATION OF WELCOME ARC AT MANRESA PARK, BARANGAY MANRESA & PROJECT NO. 21-001SV** and the City has accepted the Bid for **TWO HUNDRED FORTY FOUR THOUSAND NINETY FIVE PESOS & 47/100 CTVS. (P 244,095.47)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

  - (h) Notice of Award of Contract and the Bidder's conforme thereto;
  - (i) Other contract documents that may be required by existing laws and/or the Entity.

6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
