DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS THROUGH ALTERNATIVE METHOD OF PROCUREMENT

- WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Request for Quotation / Proposal (RFQ) dated May 04, 2021 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on May 07, 2021, for seven (7) infrastructure projects of the City Government;
- WHEREAS, a total of forty three (43) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS, during the scheduled opening of quotation/offer held on May 07, 2021, thirty (30) bid proposals were received and opened and, after examination of said documents, seven (7) were declared passed and their corresponding bid price read while twenty three (23) were declared failed;
- WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;
- NOW THEREFORE RESOLVED by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on May 07, 2021:

JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

MADSAM ENTERPRISES a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 78 f Laurena Street, Barangay 1, Tanuan City, Batangas and herein represented by MS. AGNES RUFFA M. DIMAPILIS in her capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED REHABILITATION* (SURFACE IMPROVEMENT) OF JADE STREET (NELSONVILLE SUBDIVISION), BARANGAY BATASAN HILLS & PROJECT NO. 21-009N and the City has accepted the Bid for EIGHT HUNDRED SIXTY ONE THOUSAND EIGHT HUNDRED FORTY SIX PESOS & 48/100 CTVS. (\$\mathbb{P}\$ 861,846.48) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (f) Eligibility requirements, documents and/or statements;
 - (g) Performance Security;
 - (h) Notice of Award of Contract and the Bidder's conforme thereto;
 - Other contract documents that may be required by existing laws and/or the Entity.

- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
