RESOLUTION NO. SV02; S - 2021

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS THROUGH ALTERNATIVE METHOD OF PROCUREMENT

- WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Request for Quotation / Proposal (RFQ) dated September 30, 2021 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on October 5, 2021, for thirteen (13) infrastructure projects of the City Government;
- WHEREAS, a total of thirteen (13) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS, the QC-BAC-Infra issued Bid Bulletin No. 003-2021 for rescheduling of opening of Quotations to October 11, 2021;
- WHEREAS, during the scheduled opening of quotation/offer held on October 11, 2021, seven (7) bid proposals were received and opened and, after examination of said documents, all were declared passed and their corresponding bid price read while six (6) were declared failed for non submission of bidding documents;
- WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;
- NOW THEREFORE RESOLVED by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on October 11, 2021:

CONTRACT AGREEMENT

This Contract made and entered in Quezon City, Metro Manila, this day of JAN 24 2022 , by and between:

QUEZON CITY, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

VINDESTELLE CONSTRUCTION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 137 Arce Building, Room 206 Malakas Street, Bgy. Central, Quezon City and herein represented by MS. DIGNA D. MARCIANO in her capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED REHABILITATION OF ROAD AND DRAINAGE AT BALIMBING STREET, BARANGAY VETERANS VILLAGE & PROJECT NO. 21-013SV* and the City has accepted the Bid for *NINE HUNDRED SIXTY NINE THOUSAND THREE HUNDRED FIFTY FOUR PESOS & 75/100 CTVS.* (\$\mathcal{P}\$ 969,354.75) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Drawings/Plans;
 - (b) Specifications;
 - (c) Request for Quotation;
 - (d) Addenda and/or Supplemental/Bid Bulletins, if any;
 - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (f) Eligibility requirements, documents and/or statements;
 - (g) Performance Security;
 - (h) Notice of Award of Contract and the Bidder's conforme thereto;
 - Other contract documents that may be required by existing laws and/or the Entity.

- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- That the Contractor hereby certifies that the site was regularly inspected and verified
- The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
