JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

PGM CONSTRUCTION & PLUMBING SERVICES a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at Lot 1 Blk 11 Greenlane cor. Greenvalley Streets, Greenview Phase 3, Sauyo Road, West Fairview, Quezon City and herein represented by MR. PAUL G. MARGUEZ in his capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED UPGRADING OF MAIN ELECTRICAL SERVICE ENTRANCE OF HOLY SPIRIT NATIONAL HIGH SCHOOL (MAIN CAMPUS), BARANGAY HOLY SPIRIT & PROJECT NO. 21-00061* and the City has accepted the Bid for *ONE MILLION THREE HUNDRED TWENTY THREE THOUSAND SEVEN HUNDRED ELEVEN PESOS & 38/100 CTVS. - In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- That the Contractor hereby certifies that the site was regularly inspected and verified
- The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.



DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

- WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated June 10, 2021 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on July 05, 2021, for eighteen (18) infrastructure projects of the City Government;
- WHEREAS, a total of forty three (43) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS, during the scheduled public bidding held on July 05, 2021, forty three (34) bid proposals were received and opened and, after examination of said documents, thirty (30) were declared passed and their corresponding bid price read while four (4) were declared failed;
- WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;
