RECOMMENDING THE AWARD OF THE PROJECT PROCURED THROUGH PUBLIC BIDDING

WHEREAS, on **March 28, 2022**, the BAC conducted public bidding for the procurement of various goods and services enumerated in the Invitation to Bid (IB) posted on **March 8, 2022**, pursuant to the provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (RIRR);

WHEREAS, the BAC has observed all the requirements and procedures prescribed by R.A. 9184 and its RIRR in the Opening of Bids including the bid evaluation and post-qualification of the **Single Calculated and Responsive Bid**;

WHEREAS, on 16 December 2021, the Commission on Election (COMELEC) issued Resolution No. 10747 entitled: "Rules and Regulations on Prohibition Against Release, Disbursement or Expenditures of Public Funds and Construction of Public Works, and Issuance of Treasury Warrants and Similar Devices (Section 261 (V), (W) of the Omnibus Election Code in Connection with the May 9, 2022 Synchronized National and Local Elections";

WHEREAS, on 28 February 2022, this City filed before the COMELEC a Petition for the Issuance of Certificate of Exception for the Social Welfare Projects and Services of the Quezon City Government;

WHEREAS, on 23 March 2022, the COMELEC En Banc resolved to partially grant the Petition for certain social welfare projects namely; Financial Assistance for Frontliners; Free Maintenance Medicine Assistance; Financial Assistance Program – Burial Assistance and the Scholarship Programs.

WHEREAS, the following bidder participated in and submitted its bid on the projects for evaluation and passed the post-qualification process and may now be considered and declared as the **Single Calculated and Responsive Bid**, to wit;
