RESOLUTION NO. SP- 8978, S-2022

A RESOLUTION AMENDING RESOLUTION NO. SP-8762, S-2021, ENTITLED "A RESOLUTION RENEWING THE SPECIAL PERMIT OF AB LEISURE EXPONENT, INC. TO OPERATE AN ELECTRONIC BINGO (E-BINGO), AND ELECTRONIC GAMES (E-GAMES) AT THE 4TH FLOOR, UNITS 2, 3, 4, AND 5 NEW FARMERS PLAZA, ARANETA CENTER, BARANGAY SOCORRO, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)", BY WAY OF CHANGING THE WORDS "ELECTRONIC GAMES (E-GAMES)" TO "TRADITIONAL BINGO".

WHEREAS, AB Leisure Exponent, Inc. is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at the 4th Floor, Units 2, 3, 4, and 5 New Farmers Plaza, Araneta Center, Barangay Socorro, District III, Quezon City;

WHEREAS, AB Leisure Exponent, Inc. is primarily engaged in the business of Electronic Bingo (E-Bingo) and Traditional Bingo;

WHEREAS, to enable the applicant to operate an Electronic Bingo and Traditional Bingo in Quezon City, there is a need to amend Resolution No. SP-8762, S-2021, by changing the words Electronic Games (E-Games) to "Traditional Bingo".
