A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE VARIOUS EQUIPMENT CHARGEABLE AGAINST THE CITY'S GENERAL FUND FOR DISTRIBUTION TO THE VARIOUS BARANGAY HALLS, BARANGAY HEALTH CENTERS, ELEMENTARY/HIGH SCHOOLS, HOMEOWNERS ASSOCIATIONS/ PEOPLE'S ORGANIZATIONS WITHIN THE  $6^{\text{TH}}$  LEGISLATIVE DISTRICT OF QUEZON CITY AND TO TRANSFER THE OWNERSHIP OF THE SAID EQUIPMENT TO THE RECIPIENTS WITHOUT COST, THROUGH THE EXECUTION OF THE RELEVANT DEED OF DONATION.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, Honorable Ma. Josefina G. Belmonte, to purchase various equipment chargeable against the city's General Fund for distribution to the various barangay halls, barangay health centers, elementary/high schools, homeowners associations/ people's organizations within the 6th Legislative District of Quezon City and to transfer the ownership of the said equipment to the recipients without cost, through the execution of the relevant Deed of Donation.
