WHEREAS, pursuant to Section 455 (b)(1)(v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Chief Executive, acting as Appointing Authority, shall "Appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in this Code, as well as those he may be authorized by law to appoint";

WHEREAS, the City Mayor, Honorable Ma. Josefina G. Belmonte, has appointed Karen Santos Sagun as City Government Assistant Department Head III (SG-25) - (1st STEP) under the permanent status at the Quezon City Center for Children with Disabilities;

WHEREAS, Section 454(d) of the same Code requires that appointments of heads of department and offices issued by the City Mayor shall be with the concurrence of the City Council;




WHEREAS, the confirmation of the appointment of Karen Santos Sagun as City Government Assistant Department Head III (Director I) of Quezon City Center for Children with Disabilities of Quezon City will complete the substantive and procedural requirements set forth by the Civil Service Rules and Regulations regarding the nature of her appointment.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to confirm, as it does hereby confirm, the appointment issued by the City Mayor, Honorable Ma. Josefina G. Belmonte, to Karen Santos Sagun as City Government Assistant Department Head III (Director I) of the Quezon City Center for Children with Disabilities.
