WHEREAS, to help further establish gardens, landscape, and tree plants throughout Quezon City and to speed up their mobility, the Parks Development and Administration Department needs a Mini Dropside Truck Vehicle to be utilized for the delivery of their services, as well as in their operation and maintenance;

WHEREAS, considering the significant amount of funds that can be saved from payment of annual insurance coverage and the renewal of registration, the City General Services Department recommended the transfer and donation of the subject vehicle to the aforementioned Department of the Local Government Unit of Quezon City without cost.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate, one (1) unit of Mitsubishi Mini Dropside Truck to Parks Development and Administration Department (PDAD), Quezon City and authorizing the transfer of ownership of the said vehicle to the recipient without cost.

RESOLVED FURTHER, that the ownership of the said vehicle be transferred to the recipients through a Deed of Donation, to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte and Councilor Ivy L. Lagman as the Donors, the Department Head of the concerned department as the Donee, and the Head of the City General Services Department (CGSD).

RESOLVED FURTHERMORE, that the Parks Development and Administration Department (PDAD) be authorized to appropriate funds for the payment of the required insurance and registration fees of this donated vehicle.

RESOLVED FINALLY, that the copies of this Resolution along with the Deed of Donation be given to the recipient department, the Office of the City Mayor, the City General Services Department, and the Office of Councilor Ivy Lagman for their records and references.
