EXECUTIVE ORDER NO. 2019

CREATING TASK FORCE BUILD 5

WHEREAS, the Department of Transportation (DOTr), the Department of Public Works and Highways (DPWH), private proponents and other agencies will straddle Quezon City with at least five major infrastructure projects. These projects include the Metro Manila Subway, MRT-7, Skyway Stage 3, Segment 8.2 of the North Luzon Expressway (NLEX), and the resettlement of around 18,000 families of informal settlers;

WHEREAS, these projects align with the national government's "Build, Build Build" program;

WHEREAS, these projects will massively impact the lives of Quezon City residents and businesses; among others, the involved agencies must acquire land, close roads, re-route traffic, mitigate construction hazards, relocate tens of thousands of people, ensure safety and maintain order at the project sites;

WHEREAS, under the Mayor's inaugural address, we adopted the motto, "Serving with our Hearts and Planning with our Heads." In this light, the City Government must ameliorate these social impacts to the greatest extent possible, always bearing in mind the best interest of Quezon City's people;

WHEREAS, to address these social impacts, the City government, the DOTr, DPWH and other involved agencies and proponents must closely coordinate a comprehensive social preparation and information campaign;

WHEREAS, DOTr Department Order No. 2017-011 emphasizes the critical role of local governments in public transport planning.

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do order:

SECTION 1. CREATION. The Quezon City Build 5 Task Force is hereby created.

SECTION 2. COMPOSITION. The Task Force shall be composed of the following:

SMC Mass Rail Transit 7, Inc. project representative

At any time, the City Mayor may amend the Task Force's membership as needed.

SECTION 3. FUNCTIONS. Task Force Build 5 shall (i) coordinate the activities of the Quezon City government, national government agencies and private proponents, with a view to mitigating and ameliorating the social impacts of the above-mentioned projects on the people of Quezon City; (ii) prepare and implement a cohesive social preparation, public relations and information campaign, to ensure the participation, cooperation and awareness of Quezon City stakeholders in respect of project benefits, developments and requirements; and (iii) act as liaison on any relevant issue or concern requiring multi-sectoral or multi-agency collaboration.

In relation to foregoing, the Quezon City Task Force for Transport and Traffic Management shall handle any relevant field work or operational matters. On the other hand, the Quezon City Task Force for Transportation Planning shall handle any detailed planning that may be required.

SECTION 4. SECRETARIAT. The Secretariat of the Task Force for Transportation Planning shall also act as the Secretariat of Task Force Build 5. The Secretariat shall handle Task Force Build 5's administrative, liaison, technical and operational requirements.

SECTION 5. CONSISTENCY WITH LOCAL PLANS. In so far as possible, Task Force Build 5 shall align its activities with the Quezon City Comprehensive Land Use Plan (CLUP) and the plans of the Quezon City Task Force for Transportation Planning.

SECTION 6. FUNDING. Funding requirements of the Board shall be drawn from the available funds of the Office of the Mayor, and the funds of the respective City departments or offices allocated for any relevant units to be later identified.

SECTION 8. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the President and the Metropolitan Manila Development Authority (MMDA) for information and guidance pursuant to Section 455(1)(xii) of RA

7100, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 9. EFFECTIVITY, This Order shall take effect immediately.
