## EXECUTIVE ORDER NO. 24 Series of 2022

# RESOLUTION REORGANIZING THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (QCDRRMC), AND REAFFIRMING WITH MODIFICATIONS TO THE COMPOSITION, AND ORGANIZATION THEREOF

WHEREAS, Sections 4 and 5, Article II of the 1987 Constitution establishes that the prime duty of the Government is to serve and protect the people, and that the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 16, Article II of the 1987 Constitution enshrines the State policy to protect and advance the right of the Filipino people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Section 2 (a) of Republic Act (RA) No. 10121, otherwise known as the *Philippine Disaster Risk Reduction and Management Act of 2010*, provides that it shall be the policy of the State to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, Executive Order No. 12, s. 2012, of the Office of the President reiterates the policy of the State to institutionalize the policies, structures, coordination mechanism and programs on disaster risk reduction from national down to local levels; recognize the local risk patterns across the country and strengthen the capacity of Local Government Units (LGUs) for disaster risk reduction and management through decentralized powers, responsibilities, and resources at the regional and local levels;

WHEREAS, pursuant to RA No. 10121, the Quezon City Government through local Executive Order No. 23, s. 2010 organized the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), subsequently strengthening and reorganizing the same through succeeding issuances and legislation;

WHEREAS, as enunciated during the inaugural address of the Mayor, the Quezon City Government is henceforth adopting the policy of "SERVING WITH OUR HEARTS AND PLANNING WITH OUR HEADS." This provides clear direction with which to pursue, firstly, the Quezon City Disaster Risk Reduction and Management Plan 2014-2020 vision of Quezon City being a Quality City with an empowered and responsive citizenry who live in a sustainable, well planned, and structurally sound environment with a vibrant economy under progressive leadership; and secondly, the realization within Quezon City of Sustainable Development Goal (SDG) No. 11, to make cities and human settlements inclusive, safe, resilient and sustainable, and SDG No. 13, to take urgent action to combat climate change and its impacts.

**NOW THEREFORE, I, MA. JOSEFINA G. BELMONTE-ALIMURUNG,** Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. REORGANIZATION OF THE QCDRRMC.** The QCDRRMC, created and reconstituted by virtue of Quezon City Executive Orders pursuant to RA No. 10121, is hereby reorganized.

**SECTION 2. COMPOSITION AND ORGANIZATION.** The QCDRRMC shall be composed of the following:

2.1 Chairperson: The Quezon City Mayor

2.2 Co-Vice Chairpersons: The City Administrator

2.3 Action Officer: The Local DRRM Officer V, or as may be designated

by the Chairperson in a separate Order

2.4.1 In the course of strengthening Quezon City's resilience against disasters, and for the purposes of planning, the members shall be organized according to the following thematic areas, as provided for by Executive Order Nos. 4 and 7, s. 2019, with modifications:

Committee Functions: Identify and avoid hazards and mitigate their potential impacts by (i) reducing vulnerabilities and exposure and (ii) enhancing capacities of communities to anticipate, cope and recover from the negative effects of emergencies and disasters.

Committee Functions: (i) Restore and improve facilities, livelihood and living conditions and organizational capacities of affected communities; and (ii) reduce disaster risks in accordance with the "building back better" principle.

- 2.4.2 In the event of elevated alert levels as determined by the QC DRRM Office (QCDRRMO) in coordination with the National DRRM Council (NDRMMC), the members shall be organized according to the Response Clusters indicated in the Contingency Plans of the City.

### **SECTION 3. GENERAL FUNCTIONS OF THE QCDRRMC.** The QCDRRMC shall have the following general functions:

3.1 Approve, monitor and evaluate the implementation of the Quezon City Disaster Risk Reduction and Management Plan, including its regular and periodic review and pilot testing, or exercise of the Plan consistent with national and local disaster incident planning and response protocols.

- 3.2 Approve the Incident Command System or Protocol of the DRRMO Command, Control, Communications and Emergency Operations Center located at Kalayaan Avenue, Central, Quezon City. Ensuring at all times the interoperability of all Action and Support Service Offices under this Order with the Radio Communications Service Chief as Dispatching Officer.
- 3.3 Integrate disaster risk reduction, mitigation, climate change and resiliency plans and programs into the Local Development Plan, Programs, Work and Financial Plans as a strategic tool to ensure sustainable development and resiliency.
- 3.4 Recommend, when warranted, the implementation of forced or preemptive evacuation of communities at risk of natural or man-made disasters or calamities.
- 3.5 Conduct quarterly meetings or, when necessary, convene in order to prepare for, assess, evaluate and recommend courses of action in preparation for, or in response to an impending or recently concluded natural or man-made disaster or calamity.
- 3.6 Perform such other functions as may be directed by the QCDRRMC Chairperson or the QCDRRMC.

**SECTION 4. SECRETARIAT.** As provided by Quezon City Ordinance No. SP-2290, s. 2014, the QCDRRMO shall act as the secretariat of the QCDRRMC, and perform the following duties:

- 4.1 Act as secretariat for the QCDRRMC and provide administrative and coordinative support to the Council, including the documentation of Council meetings and proceedings.
- 4.2 Assist the Council and the QCDRRMC Action Officer in the monitoring of DRRM plans and PPAs from the Barangay to the City Department/Office level.
- 4.3 Assist the Council and the Action Officer in information and dissemination, and disaster awareness in the Barangay and the community in general.
- 4.4 Assist the Council and the Action Officer in capacity building and mainstreaming of disaster risk reduction and climate change in the development process.
- 4.5 Assist the Council and Action Officer in ensuring that disaster risk reduction and climate change measures are gender responsive and respectful of human rights.
- 4.6 The QCDRRMO shall continue to perform the functions, duties and responsibilities provided in Executive Order No. 5, s. 2013.
- 4.7 Perform other duties as may be required by the QCDRRMC Chairperson and Action Officer for the effective and efficient discharge of the Council's functions.

**SECTION 5. RESOURCE AVAILABILITY.** Members of the QCDRRMC, other departments, offices and operating units shall make their human resources, equipment, facilities and expertise available to carry out the mandated functions of the QCDRRMC.

Subject to the availability of funds, the operational requirements of the QCDRRMC may be sourced from the Five Percent (5%) Local Disaster Risk Reduction and Management Fund, subject to the usual government accounting and auditing laws, rules and regulations.

When necessary, the QCDRRMC may mobilize the resources, equipment, facilities and expertise of the private sector in support of the post-disaster recovery and rehabilitation efforts of the Quezon City Government.

**SECTION 6. REPEALING CLAUSE.** Sections 4, 8-23, and 26-27 of Executive Order No. 2, s. 2010 and Section 5 of Executive Order No. 11, s. 2016 on the Operating Teams and Units are hereby expressly repealed.

Furthermore, all prior issuances on the organization and functions of the QCDRRMC inconsistent herewith are deemed amended, modified or superseded accordingly.

**SECTION 7. DISSEMINATION.** A copy of this Executive Order shall be furnished to the Office of the President and the Metro Manila Development Authority (MMDA) for information and guidance pursuant to Section 455 (1) (xii) of RA No. 7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 8. EFFECTIVITY. This order shall take effect immediately.
