## EXECUTIVE ORDER NO Series of 2022

CREATING THE COMMITTEE ON ACCREDITATION, SELECTION AND MONITORING OF CIVIL SOCIETY ORGANIZATIONS, PRIVATE SECTORS AND SIMILAR AGGRUPATIONS IN QUEZON CITY, DEFINING ITS COMPOSITION, MANDATE AND FOR OTHER PURPOSES

WHEREAS, the Philippine Constitution provides that the State shall facilitate the establishment of adequate consultation mechanisms for genuine people's participation in local governance;

WHEREAS, the Local Government Code of 1991 provides that local government units shall promote the establishment and operation of People's (POs) and Non-Governmental Organizations (NGOs)/Civil Society Organizations (CSOs) to become active partners in the pursuit of local autonomy;

WHEREAS, the Implementing Rules and regulations of the Local Government Code 1991 mandates local government units to promote the establishment and operation of People's Organizations, Non-Government Organizations/Civil Society Organizations (CSOs) and the Private Sector, to make them active partners in the pursuit of local autonomy, and to directly involve them in the plans, programs and projects or activities of the local government unit, such as, but not limited to, membership in Local Special Bodies (LSBs) and involvement in the delivery of basic services and facilities;

WHEREAS, there is a need to institutionalize and strengthen the constitutional and codal provisions to encourage continuous people's support and meaningful participation in the development of the city.

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. CREATION - There is hereby created a Committee on Accreditation, Selection and Monitoring of People's Organizations, Non-Governmental Organizations/Civil Society Organizations and Private Sector in Quezon City which shall be composed of the following departments and offices which shall also be known as the Executive Committee:

**SECTION 2. MANDATE** - The Committee on Accreditation, Selection and Monitoring of People's and Non-Government Organizations/Civil Society Organizations and Private Sector shall discharge the following duties and functions:

- a) Promote and mobilize People and Non-Government Organizations/Civil Society Organizations and Private Sector's participation in governance;
- b) Formulate plans, policies and programs to effectively ensure people's participation in the Local Special Bodies;
- c) Facilitate and monitor POs/NGOs/CSOs/Private Sector's accreditation and election in the Local Special Bodies;
- d) Other duties and functions as may be assigned by the Mayor from time to time.

SECTION 3. TECHNICAL WORKING GROUP (TWG) - A Technical Working Group (TWG) is an organized technical and administrative assistance group which shall act on matters requiring the Committee's immediate action, which shall be headed by the Barangay and Community Relations Department, and shall be composed of designated personnel as the Committee's Secretariat. The TWG shall be composed of Fifteen (15) representatives from the following:

- a) Two (2) from DILG QC
- b) One (1) from the Office of the Mayor
- c) One (1) from the Office of the Vice Mayor
- d) Three (3) from the Office of the Secretary to the Sangguniang Panlungsod
- e) Seven (7) from the Barangay and Community Relations Department
- f) One (1) from the City Planning and Development Department

**SECTION 4. FUNCTIONS OF THE TWG** - The TWG shall be responsible for the following:

- a) Ensure that the decisions of the Executive Committee are faithfully carried out;
- b) Provided technical support to the Executive Committee;
- c) Prepare reports, documents, proceedings and activities of the Committee;
- d) Assist the Executive Committee in the performance of its duties and functions;
- e) Provide the Executive Committee with the data and information essential to the formulation of plans, programs and activities; and
- f) Perform other functions as may be assigned by the Executive Committee.

**SECTION 5. INDICATIVE ACTIVITIES** - The following shall be the minor activities of the Committee which shall be complied with in accordance with the time frame as indicated:

**SECTION 6. DISSEMINATION** - A copy of this Executive Order shall be furnished to the Office of the President and the Metropolitan Manila Development Authority (MMDA) and for this information and guidance pursuant to Section 455 (1) Paragraph (xvii) of Republic Act No. 7160 (Local Government Code of 1991), as amended.

**SECTION 7. REPEALING CLAUSE** - All other orders, issuances, rules and regulations or parts thereof, which are inconsistent with this Executive Order are hereby repealed, amended or superseded accordingly.

SECTION 8. EFFECTIVELY - This Order shall take effect immediately.
