EXECUTIVE ORDER NO. 36

**RECONSTITUTING THE QUEZON CITY INFRASTRUCTURE COMMITTEE,
ITS TECHNICAL WORKING GROUP (TWG) AND THE SECRETARIAT**

WHEREAS, there is a need to regularly assess the vital infrastructure needs of the City;

WHEREAS, the implementation of the infrastructure needs of the City should go hand-in-hand with the thrust of the city to maximize delivery of services to its residents;

WHEREAS, there is a need to reconstitute the infrastructure committee to intensify the process of evaluation of project proposals and ensure its effective implementation.

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do order:

SECTION 1. QUEZON CITY INFRASTRUCTURE COMMITTEE (INFRACOMM). The Quezon City Infrastructure Committee (INFRACOMM), its Technical Working Group (TWG) and the Secretariat is hereby reconstituted which shall be composed of the following:

The Technical Working Group (TWG) which requires technical expertise and the Secretariat shall be appointed by the INFRACOMM.

SECTION 2. FUNCTIONS. The INFRACOMM shall have the following functions, to wit;

- a. Conduct continuing studies and consultations with various sectors of the city and different agencies to determine the infrastructure needs of the city as well assess the resiliency of infrastructures owned and

operated by the City in preparation for any disasters like earthquakes, floods, typhoons or power outages;

- b. Prioritize identified infrastructure project proposals according to its degree of urgency and availability of funds;
- c. Cause the preparation of technical documents, plans and cost estimate for priority infrastructure project proposals; and
- d. Recommend to the City Mayor, projects which can be implemented.

SECTION 3. SECRETARIAT. The Secretariat shall be responsible for providing assistance to the INFRACOMM, the performance of their functions, specifically on the provision of administrative and logistical services, preparation of meeting agenda, and documentation of meeting and INFRACOMM-related activities as well as reporting to the Office of the City Mayor.

SECTION 4. CONVENING OF THE INFRACOMM. The INFRACOMM shall schedule a meeting every quarter, or as often as needed.

SECTION 5. FUNDING. Until such time that the INFRACOMM is given budget for the purpose stated herein the funding necessary to carry out its functions shall be sourced from the Office of the City Mayor or from any available funds of the City in accordance with the accounting and auditing management and procedures, other existing laws, rules and regulations.

SECTION 6. HONORARIA. The INFRACOMM, TWG members and Secretariat are authorized to receive honoraria subject to the usual accounting and auditing rules.

SECTION 7. REPEALING CLAUSE. All prior Orders, Issuances or Guidelines inconsistent herewith are amended, modified or superseded.

SECTION 8. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the President and the Metropolitan Manila Development Authority (MMDA) for information and guidance pursuant to Section 455(1)(xii) of RA 7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 9. EFFECTIVITY. This Order shall take effect immediately.
