**RECONSTITUTING THE QUEZON CITY SEXUALLY TRANSMITTED
INFECTION, ACQUIRED IMMUNE DEFICIENCY SYNDROME COUNCIL
(QCSAC) DEFINING ITS FUNCTIONS AS PROVIDED FOR UNDER ORDINANCE
NO. SP-2504, S-2016 AND OTHER EXISTING LAWS PERTINENT THERETO AND
FOR OTHER PURPOSES**

WHEREAS, Section 15, Article II, of the 1987 Philippine Constitution provides that the state shall protect and promote the right of the people and instill health consciousness among them;

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides that the state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and that there shall be priority for the needs of the under-privileged, sick, elderly, disabled, women and children;

WHEREAS, the Quezon City Government recognizes the alarming effect of Human Immunodeficiency Virus (HIV), Acquired Immune Deficiency Syndrome (AIDS) and other Sexually Transmitted Infections (STI) as major health threats;

WHEREAS, the Quezon City Government recognizes HIV/AIDS and other STIs and that it will meet the challenges of preventing and controlling the spread of the diseases;

WHEREAS, the Quezon City Council enacted Ordinance No. SP-2601, S-2017 entitled, "An Ordinance mandating the provision of information, education and communication materials on reproductive health and on the prevention and control of Human Immunodeficiency Virus (HIV), Acquired Immunodeficiency Syndrome (AIDS), and Sexually Transmitted Infection (STI) in public secondary schools in Quezon City, and appropriating funds thereof";

WHEREAS, Ordinance No. SP-839, S-99 creating the QCSAC defining its functions and membership and for that purpose, ordinance No. SP-1053, S-2001 was enacted strengthening the Quezon City STD/AIDS Council implementing the policies and measures for the prevention and control of STD, HIV and AIDS in Quezon City;

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of powers vested in me by law, do hereby reconstitute the Quezon City STI/AIDS Council (QCSAC):

SECTION 1. RECONSTITUTION OF THE COUNCIL. Pursuant to Ordinance No. SP-838, S-99, and to carry out the policies as provided for under Ordinance No. SP-2504, S-2016 amending Ordinance no. SP-1053, S-2001 otherwise known as the "Quezon

City AIDS Prevention and Control Ordinance", the Quezon City Sexually Transmitted Infections / Acquired Immune Deficiency Syndrome (STI/AIDS) Council (QCSAC) is hereby reconstituted and shall be composed of the following:

Chairperson: City Mayor
Co-Chairperson: City Vice Mayor
Vice Chairperson: Head, City Health Department

Chairperson, Committee on Social Services, *Sangguniang Panlungsod*

Chairperson, Committee on Health and Sanitation, *Sangguniang Panlungsod*

Chairperson, Committee on Women, Family Relations and Gender Equality, *Sangguniang Panlungsod*

Head, Social Services Development Department (SSDD)

Head, Department of Public Order and Safety

Head, Barangay and Community Relations Department

President, *Liga ng mga Barangay - QC*

Head, QC Youth Development Office

Superintendent, Schools Division Office

Representative from Quezon City Pride Council

Director, Quezon City General Hospital

Director, Novaliches District Hospital

Director, Rosario Maclang Bautista General Hospital

Non-Permanent Members:

Accredited or recognized Non-Government Organizations (NGOs), Community-based Organizations (CBOs), Corporate Non-Profit Organization, and Development Partners with mandate on HIV and AIDS program.

SECTION 2. COMMITTEES AND TECHNICAL WORKING GROUP (TWG).

The Council may create committees and Technical Working Groups to carry out the

provisions of Ordinance No. SP-838, S-99 and SP-2504, S-2016 amending Ordinance No. SP-1053, S-2001.

SECTION 3. SECRETARIAT. The Secretariat for the Council shall be composed of representatives from the City Administrator's Office.

SECTION 4. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the President and the Metro Manila Development Authority (MMDA) for information and guidance, pursuant to Section 455 (1) (xii) of RA 7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 5. REPEALING CLAUSE. All issuances, orders, guidelines, rules and regulations inconsistent herewith are hereby repealed, amended or modified accordingly.

SECTION 6. EFFECTIVITY. This Order shall take immediately
