**EXECUTIVE ORDER NO. 41**  
Series of 2019

**REINSTATING THE GRANT OF MONTHLY ALLOWANCES TO ELECTION OFFICERS  
AND ELECTION ASSISTANTS ASSIGNED AT THE COMMISSION ON ELECTIONS  
(COMELEC) - QUEZON CITY FIELD OFFICE IN THE AMOUNT OF THREE  
THOUSAND PESOS (P 3,000.00) AND TWO THOUSAND PESOS (P 2,000.00),  
RESPECTIVELY**

WHEREAS, Election Officers and Election Assistants of COMELEC-QC are our front liners during the election period from voter's registration, filing of certificates of candidacy, up to the canvassing of returns and proclamation of elected officials;

WHEREAS, the Quezon City Government previously extended an allowance of Three Thousand Pesos (P 3,000.00) to Election Officers and Two Thousand Pesos (P 2,000.00) to Election Assistants, to mitigate the effect of the inflation of prices of basic commodities, and there is a need to reinstate this grant;

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. MONTHLY ALLOWANCE** - The monthly allowance for Election Officers and Assistants of the Commission on Elections-Quezon City (COMELEC-QC) Field Officer are hereby set at Three Thousand Pesos (P 3,000.00) and Two Thousand Pesos (P 2,000.00) for Election Assistant, respectively.

**SECTION 2. QUALIFICATIONS** - The allowance provided for Election Officers and Assistants, shall be conditional upon the following:

2.1 Personnel must have been and currently assigned to Quezon City for a period of One (1) Year and not less than Six (6) Months, immediately preceding the issuance of this Order;

2.2 Personnel while being assigned to Quezon City must have been evaluated or rated, "Very Satisfactory;" and

2.3 Personnel must not be receiving any other additional benefits, honorariums or per diems from the Quezon City Government.

SECTION 3. FUNDING - The budget of the monthly allowance herein provided shall be taken from the funds of the Office of the Mayor or from any available funds of the City in accordance with the government accounting and auditing management and procedures, other existing laws, rules and regulations.


SECTION 4. REPEALING CLAUSE - All other orders, issuances, rules and regulation or parts thereof which are inconsistent with this Executive Order are hereby repealed, amended or modifies accordingly.

SECTION 5. SEPARABILTY CLAUSE - If, for any reason, this Order or part hereof shall be held unconstitutional or invalid, other parts hereof shall remain in full force and effect.

SECTION 6. DISSEMINATION. Pursuant to Section 455 no. (1) Paragraph (xii) of R.A 7160 otherwise known as the Local Government Code of 1991, a copy of this Executive Order shall be furnished to the Office of the President and the Metropolitan Manila Development Authority (MMDA) for their information and guidance.

SECTION 7. EFFECTIVITY. This Order shall take effect immediately.
