



EXECUTIVE ORDER NO. 46
Series of 2019

**CONVENING THE PUBLIC-PRIVATE PARTNERSHIP (PPP) SELECTION
COMMITTEE**

WHEREAS, City Ordinance No. SP-2336, series of 2014, was enacted providing the "Quezon City Code pursuing a Public Private Partnership towards Development, providing for the procedure for selecting the private sector proponent adopting a contract management framework, and providing for appropriations and for other purposes;"

WHEREAS, there is a need to organize and convene the Public-Private Partnership Selection Committee (PPP-SC), as provided under Section 14 of the Ordinance, to act as the responsible body for all aspects of the pre-selection and selection of private sector proponents for PPP projects;

WHEREAS, there is also a need to organize the PPP Regulatory Authority (PPP-RA), as provided for under section 20 of the Ordinance, once the PPP SC has been operationalized, to perform contract management functions, such as partnership management, performance or delivery management, and contract administration, among various functions;

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Membership of the PPP Selection Committee. The following are appointed as members of the PPP Selection Committee, in accordance with its composition as provided for in the Ordinance:

Chairperson: City Mayor, or the City Administrator, if designated by the City Mayor

Secretary: City Attorney

Members: City Treasurer

City Planning and Development Officer

The Majority Floor Leader, *Sangguniang Panlungsod*

Two (2) representatives from and chosen by Civil Society

Organizations, people's and non-governmental organizations that are members of the City Development Council

SECTION 2. Convening of the PPP Selection Committee. The Secretary shall organize the first meeting of the PPP SC on any convenient date. For this purpose, the City Attorney is hereby ordered to form the members of his secretariat to properly organize this meeting.

The following shall constitute the agenda items for the first meeting:


- a. Action on the proposed Implementing Rules and Regulations (IRR) of the Ordinance;
- b. Development of the Priority List of Quezon City PPP Projects;
- c. Organization of the PPP Regulatory Authority (PPP RA)

SECTION 3. Repealing Clause. All executive orders, circulars, memoranda and other issuances inconsistent with the provisions of this Executive Order are hereby repealed, amended or modified accordingly.

SECTION 4. Dissemination. A copy of this Executive Order shall be furnished to the Office of the President and the Metro Manila Development Authority (MMDA) for information and guidance, pursuant to Sec. 455(1)(xii) of RA 7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 5. Effectivity. This Order shall take effect immediately.
