EXECUTIVE ORDER NO. 47

**CONVENING THE PUBLIC-PRIVATE PARTNERSHIP  
REGULATORY AUTHORITY (PPP-RA)**

WHEREAS, pursuant to City Ordinance No. SP-2336, s-2014, the Public Private Partnership (PPP) Selection Committee (PPP-SC) was convened by virtue of Executive Order No. 46 s-2019;

WHEREAS, in the operationalization of the PPP-SC, it now becomes necessary to convene also the PPP Regulatory Authority (PPP-RA) as provided for in Section 20 of City Ordinance No. SP-2336, s-2014, to execute its contract management functions;

NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. In accordance with Ordinance No. SP-2336, s-2014, the PPP Regulatory Authority (PPP-RA) is hereby convened and shall be composed of the following:

- Chairperson: City Mayor, or the City Administrator, if designated by the City Mayor
- Vice Chairperson: City Vice Mayor, or a representative from the *Sangguniang Panlungsod*, designated by the City Vice Mayor
- Members: Two (2) representatives of the *Sangguning Panlungsod*, belonging to two (2) distinct registered political parties to which the Mayor does not belong, to be chosen on the basis of proportional representation of all parties represented in the *Sangguniang Panlungsod*
- City Attorney
- City Treasurer
- City Planning and Development Officer
- Two (2) representatives from and chosen by accredited Civil Society Organizations, people's and non-governmental organizations who are members of the City



Development Council, and are not the same representatives in the PPP-SC

SECTION 2. The PPP-RA shall perform its functions, duties and responsibilities in the regulation and contract management of PPP projects as provided for in Chapter IV of the Ordinance and made as an integral part of this Order.

SECTION 3. The PPP-RA shall be provided secretariat and support services by the City Legal Department. Accordingly, it shall assist in the conduct of meetings, take charge of communications and notices, prepare reports and take custody of all records, data information, documents and contract management manuals approved by the PPP-RA. For this purpose, the City Attorney is hereby ordered to form the members of its secretariat and support staff to properly organize its first meeting.


When necessary, the Chairperson may assign and designate other city government personnel to perform roles and functions relative to and necessary for the proper conduct of all relevant activities and proceedings.

SECTION 4. All executive orders, circulars, memoranda and other issuances inconsistent with the provisions of this Executive Order are hereby amended, modified or repealed accordingly.

SECTION 5. A copy of this Executive Order shall be furnished to the Office of the President and the Metro Manila Development Authority (MMDA) for information and guidance, pursuant to Sec. 455(1)(xii) of R A7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 6. This Order shall take effect immediately.
