**AWARDING THE CONTRACT FOR THE ACQUISITION OF GOODS AND SERVICES THROUGH
 ALTERNATIVE METHOD OF PROCUREMENT**

WHEREAS, **E.N.L. TRADING** participated in and submitted its quotations on the project for evaluation and passed the post qualification process and may now be considered and declared as the **Single Calculated and Responsive Offer**; to wit:
