ORDINANCE NO. SP- 3145 , S-2022

AN ORDINANCE PROVIDING FOR THE VARIOUS PHILHEALTH PACKAGES IN THE HEALTH CENTERS, LYING-IN CLINICS, ANIMAL BITE TREATMENT CENTER, AND SOCIAL HYGIENE CLINIC OF THE QUEZON CITY HEALTH DEPARTMENT, AND IN THE QUEZON CITY GENERAL HOSPITAL, NOVALICHES DISTRICT HOSPITAL AND ROSARIO MACLANG BAUTISTA GENERAL HOSPITAL, AND FOR OTHER PURPOSES.

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides, among others, that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health and social services available to all people at affordable cost;

WHEREAS, Section 2 of Republic Act No. 10606, as amended by Republic Act No. 7875, otherwise known as the "National Health Insurance Act of 2013, states that:

"SEC. 2. Declaration of Principles and Policies. - It is hereby declared the policy of the State to adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and to provide free medical care to paupers. Towards this end, the State shall provide comprehensive health care services to all Filipinos through a socialized health insurance program that will prioritize the health care needs of the underprivileged, sick, elderly, persons with disabilities (PWDs), women and children and provide free health care services to indigents."

WHEREAS, the Quezon City Government adheres to pertinent statutory laws affecting the operations of HCIs including, but not limited to, the Senior Citizens Act (Republic Act No. 10645), the Breastfeeding Act (Republic Act No. 7600), the Newborn Screening Act (Republic Act No. 9288), the Cheaper Medicines Act (Republic Act No. 9502), the Pharmacy Law (Republic Act No. 5921), the Magna Carta for Disabled Persons (Republic Act No. 9442), and all other laws, rules and regulations that may hereafter be passed by the Congress of the Philippines or any other authorized instrumentalities of the government;

WHEREAS, to guarantee the commitment of the Quezon City Government, particularly the Quezon City Health Department, Quezon City General Hospital, Novaliches District Hospital, and Rosario Maclang Bautista General Hospital, to the National Health Insurance Program (NHIP), there is a need to submit the Performance Commitment;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The PHILHEALTH PACKAGES are hereby established and institutionalized as follows:

SECTION 2. The City Mayor is hereby authorized to enter into agreement with PhilHealth including, but not limited to, the signing of the Performance Commitment for Health Care Institution (PC for HCI), until June 2025, for and on behalf of the various Health Centers, Lying-In Clinics, Animal Bite Treatment Center, and Social Hygiene Clinic of the Quezon City Health Department, Quezon City General Hospital, Novaliches District Hospital and Rosario Maclang Bautista General Hospital, as recipient and implementing institution.

SECTION 3. All agreements entered into by the City Mayor since July 2019 with PhilHealth including, but not limited to, the signing of the Performance Commitment for Health Care Institution (PC for HCI) prior to the approval of this ordinance is hereby ratified.

SECTION 4. All ordinances, resolutions, local issuances, or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. If for any reason, any provision of this Ordinance is declared unconstitutional or invalid, the remaining provisions not affected thereby shall continue to be in full force and legal effect.
