**EXECUTIVE ORDER NO. 48**  
Series of 2022

**REORGANIZATION OF THE CITY DEVELOPMENT COUNCIL**

**WHEREAS**, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides for the organization of the City Development Council (CDC);

**WHEREAS**, there is a need to strengthen the City Development Council (CDC) to make it a more effective institution in setting the direction for economic and social development and coordinating development efforts at the local level;

**WHEREAS**, there is a need for greater participation from the private and non-governmental organizations and to define and emphasize their significant roles in the local development process;

**WHEREAS**, Barangay participation in the City Development Council (CDC) as provided for under Section 107 (b) of Republic Act 7160 would afford their active participation in the formulation of development programs and projects;

**WHEREAS**, the City Development Council (CDC) needed to be reorganized after the Selection of Representatives to the Local Special Bodies conducted in September 2022, resulted in new members from the private and non-governmental groups replacing the thirty-one (31) outgoing City Development Council (CDC) members;

**NOW, THEREFORE, I, MA. JOSEFINA G. BELMONTE**, Mayor of Quezon City, by virtue of the powers vested in me by law and pursuant to Section 107 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, do hereby reconstitute the City Development Council of Quezon City, defining its membership, functions, responsibilities and for other purposes.

**SECTION 1. COMPOSITION.** The City Development Council (CDC) shall be composed of the following:

**SECTION 2. FUNCTIONS.** The City Development Council (CDC) shall exercise the following functions.

- a. Formulate long term, medium term and annual socio-economic development plans and policies;
- b. Formulate the medium term and annual investment program;
- c. Appraise and prioritize socio-economic development programs and projects;
- d. Formulate local investment incentives to promote the inflow and directions of private investment capital;
- e. Coordinate, monitor and evaluate the implementation of development programs; and
- f. Perform such other functions as may be provided by law or as often as may be necessary.

**SECTION 3. MEETING.** - The City Development Council (CDC) shall meet at least twice a year or as often as may be necessary.

**SECTION 4. EXECUTIVE COMMITTEE.** - The City Development Council (CDC) shall, by resolution and within three (3) months from date of the organization, create an Executive Committee to represent and act in behalf of the CDC when it is not in session.

**4.1. Composition.** The Executive Committee shall be composed of the City Mayor as Chairman, the Chairman of the Committee on Appropriations of the

Sangguniang Panlungsod, the President of the Liga ng mga Barangay and a representative of the Non-Governmental Organizations (NGOs) that is represented in the Council, as members.

**4.2 Powers and Functions.** The Executive Committee shall exercise the following powers and functions.

- a. Ensure that the decision of the City Development Council (CDC) are faithfully carried out and implemented;
- b. Act on matters requiring immediate attention or action by the City Development Council (CDC);
- c. Formulate policies, plans and programs based on the general principles laid down by the City Development Council (CDC); and
- d. Take action on matters that maybe authorized by the City Development Council (CDC except the approval of the development plans and annual investment plans.

**4.3 Meetings of the Executive Committee.** The Executive Committee shall hold meetings at least once a month. Special meetings may be called by the Chairman or by a majority of its members.

**SECTION 5. SECTORAL OR FUNCTIONAL COMMITTEE.** - The City Development Council (CDC) may form sectoral or functional committee to assist them in the performance of their functions.


**SECTION 6. SECRETARIAT.** - A Secretariat which shall be responsible for providing technical and administrative support, documenting proceedings, preparing reports and providing such assistance as maybe required by the City Development Council (CDC) is hereby constituted and shall be headed by the City Planning and Development Officer and shall consist of a core group from the City Planning and Development Department, staff from the other offices/ departments and the academe as may be deemed necessary. The Secretariat shall consist of a Technical Group and an Administrative Group.

**SECTION 7. FUNDING.** - Subject to compliance of government accounting and auditing rules and regulations, the budgetary needs pertaining to the effective operation of the City Development Council (CDC), including the payment of honoraria to the CDC members, as may hereinafter be identified, shall be allocated from available city government funds. The Council shall submit its Budgetary Requirements within thirty (30) days from its organization.

**SECTION 8. REPEALING CLAUSE.** - Any and all provision of prior orders, memoranda or any issuance which may be inconsistent herewith, are hereby repealed, revoked, amended or modified accordingly.

**SECTION 9. EFFECTIVITY.** - This Order shall take effect immediately.
