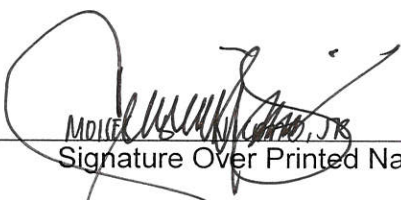

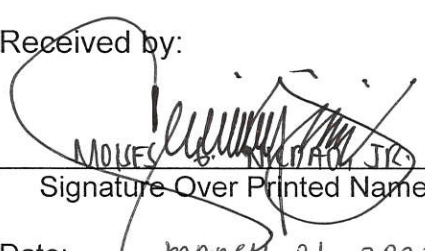

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated February 08, 2022 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on March 02, 2022, for seventeen (17) infrastructure projects of the City Government;

WHEREAS, a total of twenty six (26) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;

WHEREAS, during the scheduled public bidding held on March 02, 2022, twenty six (26) bid proposals were received and opened and, after examination of said documents, twenty three (23) were declared passed and their corresponding bid price read while three (3) were declared failed;

WHEREAS, no motion/request for reconsideration was received by the QC-BAC-Infra from bidders whose bid were declared failed;

WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;

WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;

This Contract made and entered in Quezon City, Metro Manila, this day of MAR 18 2022, by and between:

JOSEFINA G. BELMONTE**, in her capacity as City Mayor, herein after referred to as the **QUEZON CITY GOVERNMENT**;

LE BRON CONSTRUCTION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at Lot 7 Block 252 Beverly Street, Pasong Putik, Quezon City and herein represented by **MR. MOISES G. NICDAO, JR.** in his capacity as **GENERAL MANAGER** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED REHABILITATION OF DAY CARE CENTER AT DISTRICT 5 / AREA VIII (CLUSTER 1), BARANGAY GREATER LAGRO, FAIRVIEW AND NORTH FAIRVIEW & PROJECT NO. 22-00030** and the City has accepted the Bid for **NINE MILLION SEVEN HUNDRED FIFTY SIX THOUSAND THREE HUNDRED SIXTY THREE PESOS & 61/100 CTVS. (P 9,756,363.61)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

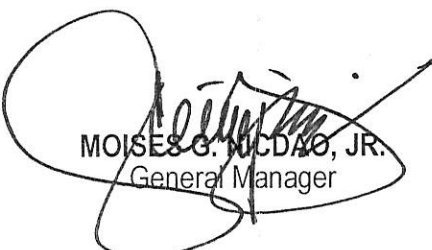
