

RESOLUTION NO. B003; S - 2022

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

- WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated February 17, 2022 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on March 16, 2022, for twenty two (22) infrastructure projects of the City Government;
- WHEREAS, a total of forty (40) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS, during the scheduled public bidding held on March 16, 2022, thirty nine (39) bid proposals were received and opened and, after examination of said documents, thirty three (33) were declared passed and their corresponding bid price read while six (6) were declared failed;
- WHEREAS, no motion/request for reconsideration was received by the QC-BAC-Infra from bidders whose bid were declared failed;
- WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;

CONTRACT AGREEMENT

This Contract made and entered in Quezon City, Metro Manila, this day of MAR 2.2 2022 , by and between:

JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

SQUARE CUBE CONSTRUCTION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at No. 12 Sta. Rita Street, San Vicente Village, Subang-Daku, Mandaue, Cebu City and herein represented by MR. ALBERT D. CAPUA in his capacity as AUTHORIZED REPRESENTATIVE hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED CONSTRUCTION OF THREE* (3) STOREY MULTI-PURPOSE BUILDING AT BARANGAY VASRA, BARANGAY VASRA & PROJECT NO. 22-00042 and the City has accepted the Bid for SEVENTEEN MILLION ONE HUNDRED ELEVEN THOUSAND ONE HUNDRED SEVEN PESOS & 22/100 CTVS. (#2 17,111,107.22) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes:
 - (i) Eligibility requirements, documents and/or statements;

- (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
