DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

- WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated October 06, 2022 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on November 03, 2022, for twenty two (22) infrastructure projects of the City Government;
- WHEREAS, a total of forty one (41) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS, the QC BAC issued Bid Bulletin No. 004-2022 Series of 2022 for the Proposed Rehabilitation of four (4) Building, Façade, Soccer Field Sidewalk and Gymnasium at Quezon City Science High School (Project No. 22-00120) for further evaluation of Technical Specification and Bill of Quatities;
- WHEREAS, during the scheduled public bidding held on November 03, 2022, thirty seven (37) bid proposals were received and opened and, after examination of said documents, thirty two (32) were declared passed and their corresponding bid price read while five (5) were declared failed and four (4) for non-submission of bidding documents;
- WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;

CONTRACT AGREEMENT

This Contract made and entered in Quezon City, Metro Manila, this day of <u>DEC 0.5.7077</u>, by and between:

QUEZON CITY, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

TRI - DG TRADING AND CONSTRUCTION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at *Unit 706, 6th Floor Bali Garden Residences, No. 140 South Zuzuaregui Street, Capitol Hills Drive, Matandang Balara, Quezon city and herein represented by MR. CARSWELL M. CABRERA in his capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;*

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED CONSTRUCTION OF HANDWASHING FACILITY AND REHABILITATION OF COMFORT ROOMS AT BAGUMBAYAN ELEMENTARY SCHOOL, BARANGAY BAGUMBAYAN & PROJECT NO. 22-00098* and the City has accepted the Bid for *ONE MILLION FIVE HUNDRED SEVENTY FOUR THOUSAND EIGHT HUNDRED NINE PESOS & 12/100 CTVS.* (£ 1,574,809.12) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;

- Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
- (i) Eligibility requirements, documents and/or statements;
- (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
