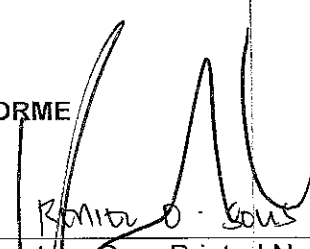

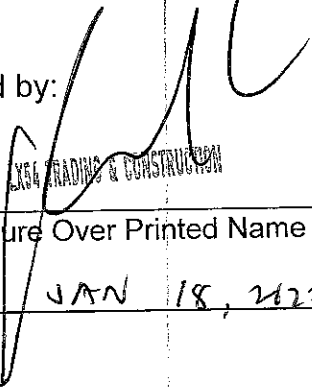

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

- WHEREAS,** the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated November 14, 2022 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on December 06, 2022, for twenty four (24) infrastructure projects of the City Government;
- WHEREAS,** a total of fifty four (54) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;
- WHEREAS,** during the scheduled public bidding held on December 06, 2022, fifty one (51) bid proposals were received and opened and, after examination of said documents, thirty six (36) were declared passed and their corresponding bid price read while fifteen (15) were declared failed and three (3) for non-submission of bidding documents;
- WHEREAS,** three (3) motion/request for reconsideration were received by the QC-BAC-Infra from bidders whose bid were declared failed;
- WHEREAS,** by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;
- WHEREAS,** evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;
- NOW THEREFORE RESOLVED** by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on December 06, 2022:

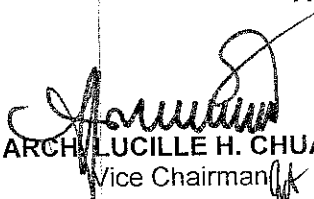

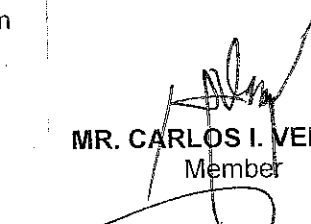

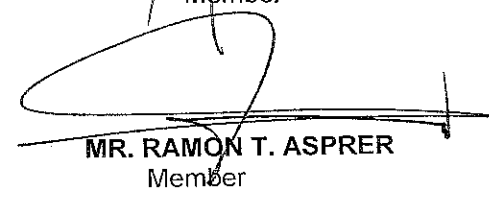

LX54 TRADING AND CONSTRUCTION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at *1210 Suntrust Capitol Plaza, Matalino, Barangay Central, Quezon City* and herein represented by **MR. RENIEL O. SOLIS** in his capacity as **GENERAL MANAGER** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED CONSTRUCTION OF SUMP PIT AT QUEZON CITY HALL COMPOUND, BARANGAY CENTRAL & PROJECT NO. 22-00138** and the City has accepted the Bid for **ONE MILLION FIVE HUNDRED FIFTY TWO THOUSAND TWO HUNDRED EIGHTY FIVE PESOS & 56/100 CTVS. 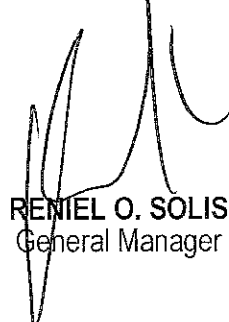

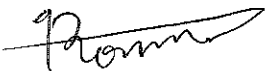
