RESOLUTION NO. 23-A-007 Series of 2023

AWARDING THE CONTRACT FOR THE ACQUISITION OF GOODS AND SERVICES THROUGH ALTERNATIVE METHOD OF PROCUREMENT

WHEREAS, the Honorable City Mayor as the Head of Procuring Entity (HoPE) approved the Indicative Annual Procurement Plan (APP) for Fiscal Year 2023;

WHEREAS, the purpose for the approval of the said Indicative APP for FY 2023 is to ensure timely delivery of goods and services of the Quezon City Government, through Early Procurement Activities (EPA) consistent with GPPB Resolution No. 14-2019 dated 17 July 2019 where the procuring entity is encouraged to start procurement activity short of award;

WHEREAS, in its Resolution No. 11-212, Series of 2022 duly approved by the City Mayor, the Bids and Awards Committee on Goods (the "Committee") recommended the use of direct contracting mode as an alternative method of procurement pursuant to Section 50 (c), RIRR of RA 9184 which provides that direct contracting is a method of procurement whereby it may be resorted for items sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the Government, the proposed acquisition merits the application of the direct contracting mode since the goods and services can only be obtained from its respective exclusive dealers/distributors;

WHEREAS, MAROON STUDIOS INC. participated in and submitted its quotation on the project for evaluation and passed the post qualification process and may now be considered and declared as Single Calculated and Responsive Offer, to wit:
