EXECUTIVE ORDER NO. 48

**CREATING THE QUEZON CITY TASK FORCE DISIPLINA, PROVIDING
FOR ITS COMPOSITION, DUTIES, FUNCTIONS AND RESPONSIBILITIES AND
FOR OTHER PURPOSES**

WHEREAS, Sections 4 and 5, Article II of the 1987 Constitution establishes that the prime duty of the Government is to serve and protect the people, and that the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 16 of Republic Act (RA) No. 7160, otherwise known as the *Local Government Code of 1991*, mandates every Local Government Unit (LGU) to exercise powers essential to the promotion of the general welfare, and within their territorial jurisdiction ensure safety, maintain peace and order, and preserve the comfort and convenience of the inhabitants;

WHEREAS, as enunciated during the inaugural address of the Mayor, the Quezon City Government is henceforth adopting the policy of *SERVING WITH OUR HEARTS AND PLANNING WITH OUR HEADS*. This provides clear direction with which to address prevailing issues in Quezon City, such as those contained in Metro Manila Development Authority Resolution No. 02-28, s. 2002 and Quezon City Council Ordinance No. SP-2068, s. 2011, and to comply with Department of Interior and Local Government Memorandum Circular No. 2019-121 in a humane and peaceful manner, pursuant to the vision of the city's 2011-2025 Comprehensive Land Use Plan of *Quezon City being a high Quality Community for living, working and playing; affording its inhabitants a high quality of living, a more prosperous economy, a safer and more livable cityscape that inspires a good sense of place and civic pride, and a well-governed constituency*, as well as the realization within Quezon City of United Nations Sustainable Development Goal (SDG) No. 11, to make cities and human settlements inclusive, safe, resilient and sustainable.

NOW THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. CREATION AND COMPOSITION. There shall be created a Task Force Disiplina under the Office of the City Mayor, and shall be composed of the following:

The Chairperson may designate additional members as needed.

SECTION 2. FUNCTIONS, DUTIES AND RESPONSIBILITIES. The Task Force Disiplina shall have the following functions, duties and responsibilities:

- 2.1 Enforce all relevant Quezon City ordinances, rules and regulations, as determined by the Task Force;
- 2.2 Enforce all ordinances, rules and regulations pertinent to the City's main thoroughfares;
- 2.3 Monitor and evaluate the Task Force's operations for further improvement;
- 2.4 Coordinate with agencies of the National Government and with all of the Barangays in Quezon City in the implementation of the Task Force's enforcement procedures;
- 2.5 Regularly meet and conduct special meetings as necessary;
- 2.6 Perform all other functions assigned by the Chairperson or Vice Chairperson.


SECTION 3. ACTION TEAM. To carry out this order, an Action Team to be headed by an Action Officer is hereby organized and attached to the Task Force Disiplina. This shall be under the direct supervision of the City Mayor as the Chairperson of the Task Force. It shall be the implementing arm of the Task Force.

SECTION 4. RESOURCE AVAILABILITY. Funds necessary to carry out the functions of the Task Force Disiplina shall be sourced from the available funds of the Office of the City Mayor.

SECTION 5, *DISSEMINATION*. A copy of this Executive Order shall be furnished to the Office of the President and the Metro Manila Development Authority for information and guidance, pursuant to Section 455 (1) (xii) of RA 7160, as amended, and shall be posted at the official website of the Quezon City Government.

SECTION 6. *EFFECTIVITY*. This Order shall take immediately.
