SUBSCRIPTION TO E-BOOKS FOR QUEZON CITY UNIVERSITY LIBRARY

I. Rationale and Brief Background

Due to the advancing educational technologies that bring changes in learning modality and as a requirement for a higher level of accreditation, E-Books became more in demand, with this, Quezon City University intends to acquire and invest in multidisciplinary e-Books in order to meet the demand and achieve excellence in the educational sector.

The multidisciplinary database will help the Stakeholders of the University in accessing research content 24/7.

II. Project Description

The multidisciplinary database offers a vast selection of e-Book titles from various subjects ranging from Art, Humanities & Social Science, Medical & Health Science, Business & Management, Computing, Engineering, Law to Technology & Science.

III. Project Scope of Work

1. Provide Quezon City University, 24/7 unlimited and simultaneous access
2. Access will be for 10 months subscription.
3. At the end of the ten-month period, the library can choose any number of titles to purchase, after reviewing usage statistics, up to the value of the initial pre-paid amount.
4. Mode of Access:

5. The provider shall submit a quarterly utilization report to the University.

V. Project Duration & Delivery

Project duration shall be for ten-month period and can be accessed within 15 days upon issuance of the Notice to Proceed (NTP).

VI. Approved Budget for the Contract

The approved budget for the contract is **THREE HUNDRED FIFTY THOUSAND PESOS and 00/100 only (Php 350,000.00).**

VII. Terms of Payment

Procuring entity shall pay the provider 100% of the total amount upon activation of the access.

VIII. Penalties for Breach of Contract

Failure to deliver the services according to the standards and requirements set by the Quezon City Local Government shall constitute an offence and shall be subject to penalties and or liquidated damages pursuant to RA 9184 and its revised implementing rules and regulations.

IX. Cancellation or Termination of Contract

In the event the City Government terminates the contract due to default, insolvency, or for any cause, it may enter into negotiated procurements pursuant to Section 53 (d) of RA 9184 and its IRR.


