

**TERMS OF REFERENCE
(TOR)**

**PROCUREMENT OF RICE: LINE 1
PROJECT NO. BCRD-23-FOODSTUFF-0564**

I. RATIONALE AND BACKGROUND

The City Mayor introduced her 14-point agenda which focuses on human and social services, economic development, environment and climate change, infrastructure and institutional development. One of the agenda of the Belmonte Administration under the Human and Social Services is to deliver responsive, efficient and cost-effective social services.

II. PROJECT DESCRIPTION

The Barangay Awareness Program under the Barangay Community Relations Department therefore proposes to procure Rice, packed in 5 kilos/sack as a government response to deliver cost-effective social services.

III. PROJECT SCOPE OF WORK

Supply and delivery of Rice packed in 5 kilos/sack will be distributed to different barangays and constituents of Quezon City.

IV. PROJECT STANDARD AND REQUIREMENTS

- A. As part of requirement in RA 9184, the Bidder must have completed a government or private contract that is SIMILAR in nature to this project within the last three (3) years equivalent to at least fifty percent (50%) of the approved budget for the contract (ABC).
- B. The bidder shall be responsible for the repacking of Rice packed in 5 kilos/sack.
- C. The bidder must deliver one hundred percent (100%) of all the items within thirty (30) calendar days from the issuance of the Notice to Proceed (NTP).
- D. The bidder must have at least thirty (30) repackers for the project. This should be supported by Identification Cards or proof of employment/engagement for these thirty (30) or more people.
- E. The bidder must have a warehouse with at least five hundred square meters (500 sq.m.) floor space to be used for the repacking of Rice packed in 5 kilos/sack. This should be supported by a proof of ownership or lease of agreement for the place.
- F. The bidder must have at least two (2) trucks and three (3) L-300 vehicles to be used for delivery. This should be supported by proof of ownership or lease of agreement(s).

V. PROJECT DURATION

The project duration is within thirty (30) calendar days from the issuance of the Notice to Proceed (NTP).

VI. APPROVED BUDGET FOR THE CONTRACT

The Approved Budget for the Contract is FORTY MILLION THREE HUNDRED FORTY-TWO THOUSAND, TWO HUNDRED PESOS AND 00/100 (PHP 40,342,200.00).

The project cost shall be fixed and there shall be no price adjustments applicable for the duration of the contract except when the operations costs are increased by 10% as a result of any extraordinary circumstances as determined by the National Economic Development Authority (NEDA). Pursuant to the provisions of RA 9184 and its RIRR on contract price escalation, all contract price escalation shall be approved by the Government Procurement Policy Board (GPPB).

VII. BASIS OF PAYMENT

In consideration for the Supply and Delivery of Rice packed in 5 kilos/sack as provided herein, the City shall pay the winning bidder the contract price upon delivery of all the items.


VIII. PENALTIES FOR BREACH OF CONTRACT

Failure to deliver the goods according to the standards and requirements set by the City shall constitute an offense and shall subject the supplier to penalties and/or liquidated damages pursuant to RA 9184 and its Revised Implementing Rules and Regulations (RIRR).

IX. CANCELLATION OR TERMINATION OF CONTRACT

The guidelines contained in RA 9184 and its Revised Implementing Rules and Regulations (RIRR) shall be followed in the termination of any contract. In the event the City terminated the Contract due to default insolvency, or for cause, it may enter into negotiated procurement pursuant to Section 53 (d) RA 9184 and RIRR.
