**CREATING AND CONSTITUTING THE QUEZON CITY'S 84th FOUNDATION
DAY STEERING COMMITTEE AND 2023 MANUEL L. QUEZON GAWAD
PARANGAL SELECTION BOARD**

WHEREAS, Commonwealth Act 502, as amended, was signed into law by President Manuel Luis Quezon on October 12, 1939, creating a public corporation which thereafter bears his name – Quezon City;

WHEREAS, Quezon City annually celebrates its Founding Anniversary with meaningful and fitting ceremonies and celebration;

WHEREAS, to ensure a smooth and successful celebration of the 84th Founding Anniversary of the City, there is a need to constitute a committee that shall prepare, coordinate and initiate a synchronized series of events and activities in connection with this celebration;

NOW THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the power vested in me by law, do hereby order:

SECTION 1. CONSTITUTION AND COMPOSITION. The Steering Committee is hereby created and organized to facilitate the preparation and execution of activities for the 84th Foundation Day of Quezon City, to be composed of the following;

The Secretariat for the 84th Foundation Day Committee and MLQ Gawad Parangal shall be composed of four (4) staff from the Quezon City Tourism Department, to wit;

2. Janet T. Orcino
3. Marivic M. Tolentino
4. Verzileus O. Balasabas

The Projects and Programs Officer of the QC Tourism Department is hereby directed to submit to the Office of the City Mayor for approval, a list of nominees for the Honorary Chairpersons and two (2) high-ranking officials from the QC Government.

SECTION 2. HONORARIA ENTITLEMENT. The members of the Selection Board may claim Honoria in the amount of Php 15,000.00, and members of the

Secretariat may claim Honoria in the amount of P 5,000.00, as applicable to Department of Budget and Management circulars and other relevant issuances.

SECTION 3. OPERATIONAL FUND. - The Operational Fund for the 20th Manuel L. Quezon Gawad Parangal (2023) Activity shall be charged against the 2023 appropriations under the Office of the City Mayor. The same shall be under the supervision of the City Administrator as the Chairperson of the 84th Foundation Anniversary.

Funding for other activities of the different offices and department in celebration of the 84th Foundation Anniversary shall be charged to available funds under each Department/ Office concerned.

SECTION 7. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the President and Metropolitan Manila Development Authority (MMDA) for information and guidance, pursuant to Section 455(1) (xii) of RA 7160, as amended, and shall be posed at the official website of the Quezon City Government.

SECTION 8. REPEALING CLAUSE. All orders and other issuance's inconsistent herewith are hereby repealed or amended or modified accordingly.

SECTION 9. EFFECTIVITY. This Order shall take effect immediately.
