VIRGINIA G. BRIOSO in her capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED REPAINTING OF PERIMETER GATE AND FENCE AT SAUYO ELEMENTARY SCHOOL, BARANGAY SAUYO & PROJECT NO.* 23-00001 and the City has accepted the Bid for *ONE MILLION SEVEN THOUSAND FOUR HUNDRED NINETY FOUR PESOS & 49/100 CTVS.* (\$\mu\$ 1,007,494.49) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
